As of March 31, 2026, the Fund's aggregate NAV was \$12,435.0 million, the fair value of its investment portfolio was \$25,007.9 million and it had principal debt outstanding of \$12,947.0 million. The average debt-to-equity ratio during March 2026 was approximately 0.99 times.

Status of Offering

The Fund is currently publicly offering on a continuous basis up to \$15.0 billion in Shares (the “**Offering**”). The following table lists the Shares and total consideration for the Offering as of the date of this filing (through the April 1, 2026 subscription date). The Fund intends to continue selling Shares in the Offering on a monthly basis.
