As of February 29, 2024, the Fund's aggregate NAV was \$5,952.7 million, the fair value of its investment portfolio was \$9,466.9 million and it had principal debt outstanding of \$3,861.5 million, resulting in a debt-to-equity ratio of approximately 0.65 times.
